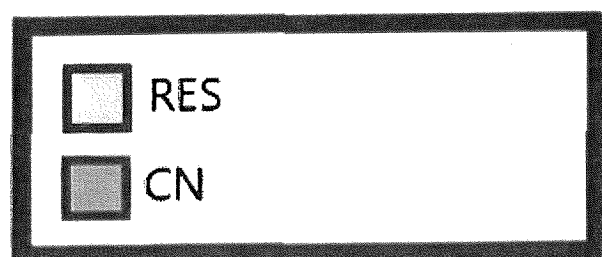
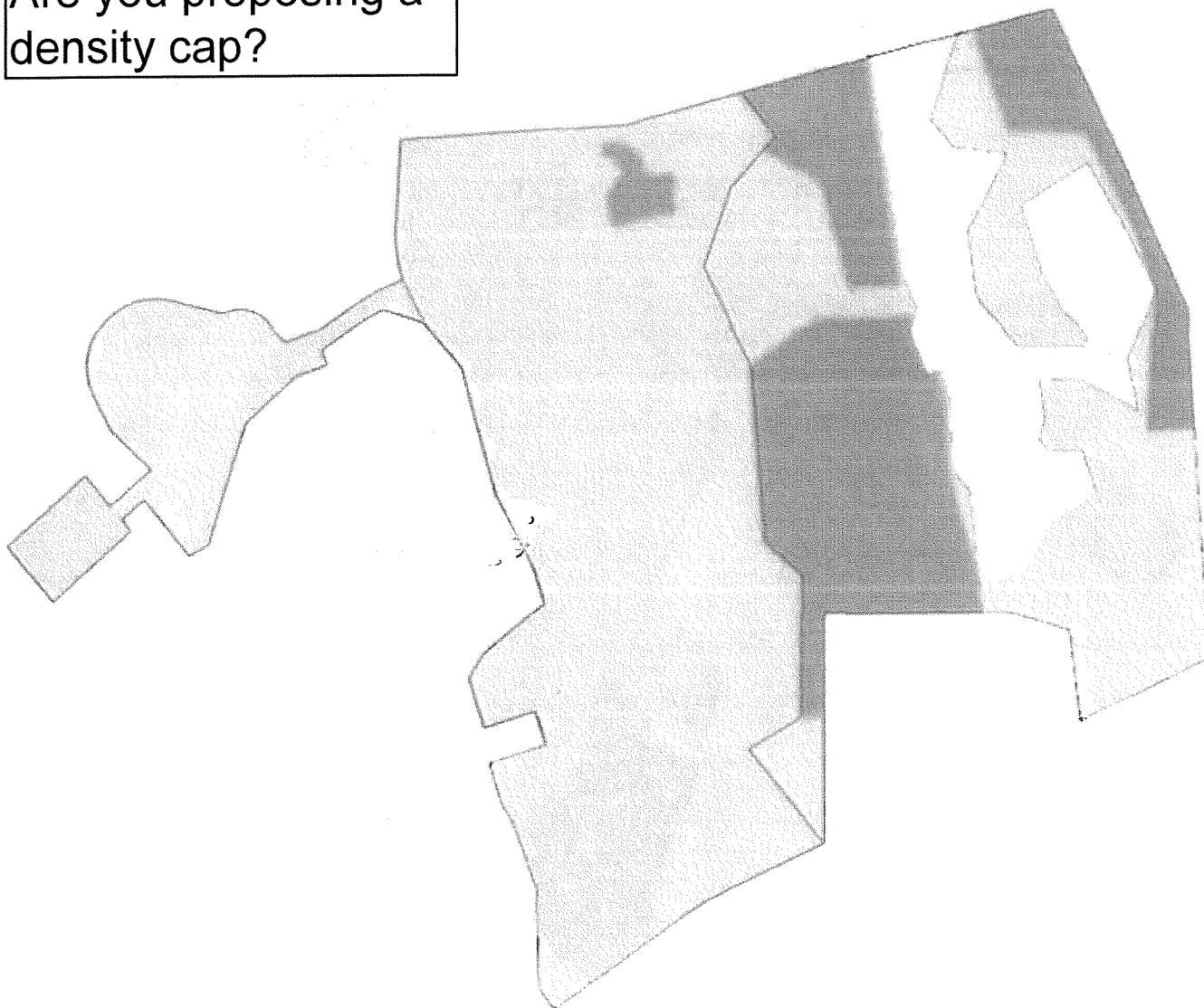

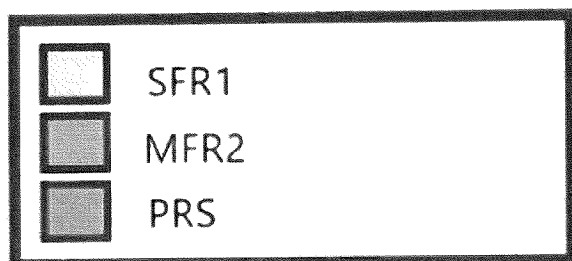
Proposed FLUM
