Re: Sol Cable (Starfish Infrastructure Inc.), FCC File No. SCL-LIC-20250910-00044 – Second Request for Additional Time to Respond

Dear Ms. Dortch:

Pursuant to section 1.40002(b)(2) of the Federal Communications Commission's (FCC or Commission) rules,¹ the U.S. Department of Justice (DOJ) respectfully requests that the FCC grant an additional two-week extension to respond to the Accepted for Filing Public Notice for the above-referenced submarine cable landing license application released on February 13, 2026.² The FCC granted DOJ's initial request for an extension and extended the deadline to Friday, March 13, 2026.³ Due to the continuing lapse in appropriation at the Department of Homeland Security (DHS), we are seeking an additional two-week extension, which would extend the filing deadline to Friday, March 27, 2026.

As DOJ explained in its last request,⁴ DHS is a member of the Committee for the Assessment of Foreign Participation in the United States Telecommunications Services Sector (Committee), of which DOJ is the Chair.⁵ DHS is subject to a lapse in appropriations that

prevents its participation in Committee reviews.⁶ DHS routinely requests that the FCC defer action on submarine cable applications and remove such applications from streamlined processing so that DHS may review the applications for national security purposes,⁷ and the FCC has accommodated such requests by removing similar applications from streamlining and referring those applications to the Committee.⁸

We anticipate that the current lapse in appropriations will prevent DHS from timely responding to the Public Notice by the extended deadline of March 13, 2026. An extension to allow DHS the opportunity to prepare and provide a response to the Public Notice is in the public interest.⁹ Accordingly, we request that the FCC grant the Committee and its member agencies a two-week extension that would establish a new filing deadline of March 27, 2026.
