**AMENDMENT TO APPLICATION**

Starfish Infrastructure Inc. (“Starfish”) submits this Amendment to its Application for a Cable Landing License (“Application”) filed on September 10, 2025 to update its FCC Form 220. Starfish makes typographical corrections throughout. In addition, Starfish makes changes to certain questions identified below:

- ***Question 3.a.*** – Starfish updates its contact for execution of lawful requests.
- ***Question 18*** – Starfish updates its response to “No”. While Starfish provided a System Route Map in Appendix A, Starfish will supplement its Application to provide specific geographic coordinates of each cable landing station in the United States and in foreign countries where the Sol cable system will land, and coordinates of any beach joint where those coordinates differ from the coordinates of the cable landing station, once available.
- ***Question 20(d1)*** – Starfish updates the Capacity-Initial to TBD.
